Dr. Wilson reported he had also received a letter from a woman mentioning that she receives oil royalties from property associated with the Laffites.

### REVISED TIME LINE

Advisory Board Member and newly elected Co-Coordinator of Research Jean L. Epperson donated for the Society's archive a July, 2004 revision of a *Tentative Chronology of John A. Laffite* [or John Matejka].

### **COPY OF 1845 MAP OF GALVESTON ISLAND**

Copies of a map on 8 ½ by 11 inch paper, f irst printed in 1945 by Bangs and reprinted by the Galveston Chamber of Commerce in 1965, courtesy of Anne A. Brindley, were handed out to members. The map shows points of location for 1) former headquarters of Aury, Mina, Perry, and Laffite; also Mexican Customs House and Amasa Turner's home, as well as the First Presbyterian Church and the Customs House.

### **COIN AND LAFFITE STATUE PRESENTATION**

Advisory Board Member and ex-officio Laffite Society President R. Dale Olson gave a presentation on his collection of Laffite commemorative coins, one set, Serial No. 6, examples of which were made of pewter, sterling silver, bronze, and gold. ### SPECIAL PRESENTATION

The following is a summary of Second Vice-President Mike Bailey's special presentation as recorded by President Mike Eubank:

Mike Bailey gave an excellent, high-tech presentation on the ACADIA, a Civil War Blockade Runner. He used his PC with an attached projector and Powerpoint as aids in the presentation. Thus, he had excellent slides with great pictures highlighting his presentation.

Mike began with a history of announcements by presidents of the South and North of new laws. Jefferson Davis had announced a privateering policy on 4/17/1861 and on 4/19/1861 Lincoln ordered a blockade of all southern coastal ports by the Union navy in which there were 74 seaworthy ships.

Types of ships in this era were: SS-screw driven steamships; TS – turbine steam ships; MV – motor driven; PS – paddle wheel, side wheeler and single wheel. The paddle wheel provided more maneuverability. Blockade runners were specifically made for that job and most were side wheelers.

The ACADIA was a River Clyde-type steamship. The ship was built in Canada in 90 days. It was a coal burning steamship and flew the Canadian flag. Construction began on 5/10/1864 in Sorel, Quebec. It left Montreal on 7/14/1864 on its maiden voyage.

The ACADIA ran aground in San Luis Pass on 2/6/1865. It was later spotted by the USS VIRGINIA, a Spanish blockade runner itself, and, because of its speed, was used in blockades by the Union navy, and destroyed by gunfire. Most of the cargo was off-loaded earlier by shore persons.

A Rice University professor, Frank Hole, salvaged different items from the wreckage in the early 1970s. He wrote a report, THE ACADIA, a CIVIL WAR BLOCKADE RUNNER, in August, 1974, TECHICAL REPORT #1, DEPARTMENT OF ANTHROPOLOGY, RICE UNIVERSITY.

Following his presentation, Mike handed out papers listing the catalogued sale items from the ACADIA and a short written report on the ACADIA [these for the Society's Archives]. He also passed around several items found in the salvage operation of the ACADIA that are from the Brazoria County Historical Museum.

### THE SHIP JUPITER

After Mike's presentation, Advisory Board Member Dr. Reginald Wilson pointed out that one of Laffite's ships, the *Jupiter*, was a side-wheeler – a bateau à vapeur (steamship) - as cited in *THE JOURNAL OF JEAN LAFFITE*, [p. 113], translated by French scholar Gene Marshall.

### **BOOK SIGNINGS BY WILLIAM DAVIS**

Dr. Wilson also reported that Advisory Board Member Pam Keyes had informed him that William "Jack" Davis would be signing copies of his new book on Laffite in New Orleans and in Houston, dates to be announced.
