### SPECIAL EVENTS

### CALL TO ORDER

The President called the meeting to order at 7:10 p.m.

### MINUTES

Minutes of the January 9th meeting were reviewed and approved.

### INTRODUCTION OF GUESTS

The following guests were introduced:

Beth Lafitte Austin and her husband, Ron. Beth is a descendant of Lafittes of Louisiana and is currently working on the genealogy of her family. Bob Lilliston, along with his wife Katie, from Overland, KS, are visitors to Galveston for the winter.

### THE LAFFITE CHRONICLES

Jim Nonus gave a status report on the Society's first publication.

- Because of its substantiality, the publication will be referred to as a "chronicle," rather than a "newsletter."
- 2) It will appear biennially rather than quarterly and will thus be of greater length and more economical to produce.

It will be considered as a most important means of informing the public of the Society's existence.

- 3) The draft of the Chronicle is now in the hands of Trisha Keele of Houston, for lay-out, and will be printed by Kopy-Kat of Houston.
- 4) The Society may assign a value to the publication with possible intention for sale.
- 5) A price scale is being considered for the following categories: a) retail in bookstores b) for members for friends & associates c) for distribution to prospective members on inquiry.
- 6) A copy will be free to members, and extra copies of the initial printing may be available for friends at no charge.

Members were encouraged to recruit others, bearing in mind not only the importance of broadening the scope of research interests in the Society, but that cost savings of printing are greater when spread over a larger number of subscriptions.

Don Marler suggested, as a cost-saving device, sending out only the cover with table of contents to prospective members.

Dick Rasche inquired if the publication would be registered with the Library of Congress. This matter will be taken under consideration with the next issue of the Chronicle in July.

### MEMBERSHIP

Randy reported 32 paid memberships to date. Since November, he has responded to 21 inquiries for information on the Society out of a total of 48 prospective members on his list. An updated copy of the Society's membership info sheet noting benefits, roster of officers, and research information sheet were made available to members. An updated membership list with research interests indicated was given out, along with the prospective member list. Randy encouraged everyone to personally contact persons whom they had suggested as prospective members, to present to them the above info in an effort to attract new membership.

### SPECIAL EVENTS

Diane reported on the recent one-day field trip Feb. 4 to the Sam Houston Regional Library and Research Center, located on the Trinity River in Liberty, TX. Mr. Robert L. Schaadt, Director of the Center presented a scholarly lecture to members on the provenance and controversy surrounding the authenticity of the "Laffite journals," published in 1958 as THE Laffite Journal: the Life and Times of a Privateer. The lecture was followed by a viewing of the Library's collection of Laffite memorabilia, including the "journal," then by a tour of former Governor Price Daniels' Greek Revival style home located adjacent to the Research

Center, and lunch at a local restaurant.

Plans for an upcoming trip to Grand Isle, Grande Terre, and New Orleans, La. May 18 through 21 were discussed. Members were given information on activities planned and on lodging at the Collins Motel (Jo Bob's) in Grand Isle and at the Hotel St. Pierre in New Orleans. Those planning to participate in this special event were urged to make hotel reservations early, and, in doing so, to mention their affiliation with the Laffite Society. Transportation will be by private car. Non-member guests are welcome.

### ARTIFACTS

Diane presented multicolored pottery shards from the Grand Isle location for members to examine.

### NEW RESEARCH INFO

Member, Will Zapalac, sent in an article to the Society on modern day Acadiens (Cajuns) and the characteristics some share with their pirate/privateer antecedents.

### SUBSCRIPTION TO FRENCH GENEALOGICAL ASSOCIATION

Dorothy reported she had sent in a personal subscription to a genealogical and historical association with an interest in the Carribean and that she had sent them the Society's membership information. The French journal, published in LePecq, France, will be made available to Society members for research.

### A PERMANENT HOME FOR THE RESEARCH COLLECTION

The President stressed the urgent need for members to offer ideas on where the growing collection (some 1,000 items) of

research material might be permanently and safely housed, and for someone with the knowledge and experience to catalogue the material. Dick Rasche offered to take on the responsibility of cataloging.

### TAPING OF MONTHLY MEETINGS

Dale emphasized the necessity of having a permanent audio or video record of speakers and their talks for the Society's archives. Don Marler offered to bring a video recorder to the next meeting March 13.

### LIST OF ORGANIZATIONS FOR DISTRIBUTION OF MEMBERSHIP INFO

Dale reported he had appointed member Randal Matthews to draw up a list of libraries in small towns of Texas and Louisiana, historical organizations, house museums, genealogical groups, newspapers, etc., to which information on The Laffite Society of Galveston can be made available. It was suggested that a letter be drafted to send to Mr. John Howells in thanks for his contribution of research material, and to Robert Schaadt, Director of the Sam Houston Regional Library and his staff for the lecture and tour at the Center Feb. 4. Mr. Schaadt asked the Society to consider including the Center in its plans for another field trip in '96.

### SPECIAL TOPIC

Jean Epperson of Dayton, TX, scheduled to present the lecture at this meeting, was unable to attend. The President therefore stepped in to speak about a set of statues and coins, depicting Laffite, minted in 1976, and the questions concerning ownership, casting and location of the dies for the medals.

The present owner claims to have a copy in his possession of Jean's and Emma's marriage certificate.

Dorothy stated she had received the first copy of a subscription to <u>Généalogie et Histoire de la Caraïbe</u> (<u>Genealogy and History of the Carribean</u>) from LePecq, France. Jean Epperson and Melanie Wiggins expressed interest in obtaining copies for their research.

Don Marler gave out updated copies of the Dogwood Press Catalogue, Spring, '95.

- 2) Received, a letter from the Director of the Centro de Apoyo á la Investigación Histórica de Yucatán, and newly published (January, '95) information on the alleged death and burial in Dzilam, Yucatán, of Pierre Laffite, brother of Jean, circa Nov. 10, 1821. A pamphlet in Spanish consisting of 18 pages of sworn testimony from witnesses loyal to the Spanish Government, focusing on events leading to Pierre's death, is currently being translated into English.
- Received, biographical information in French, from the LePecq, France Caribbean genealogical and historical association, on Pierre Laffite's life along the French-Spanish border, as well as information on other families with the surname of Laffite from the region of Bordeaux, France.

### LONG-DISTANCE TRAVELERS

### TRIBUTE TO JEAN LAFFITE FROM HIS GRAND-DAUGHTER

Dr. Reginald Wilson spoke briefly on his research into the copybooks and journal alleged to contain the writings of descendants of the Laffite brothers. He presented for members' interest a poem written in St. Louis, MO, September, 1873, by Lois Ann Little, said to be the grand-daughter of Jean Laffite, the poem inferring that Laffite may have spent his last days in quiet retirement.

### A WAYWARD CANNONBALL

Lee King, native of Gretna, LA and Laffite, LA, showed to members a photograph of a familiar representation of Jean Laffite, made, according to Mr. King, two or three years ago, and said to have been taken from the same image imprinted on a cloth square which at that time was in the possession of a Galveston family who lived on the east end of the island, names unknown.

Mr. King also had in his possession a cannonball which he stated had been retrieved some years before from a back wall in an out building located in the vicinity of 17th and Ball. A fabled story related by Mr. King, associated the cannonball with a "missed launch" toward Laffite's fort from an American ship, just prior to his departure from the island in 1821.

### DIFFERING VIEWPOINTS -- FOR THE RECORD

The President reminded members and the numerous guests assembled that the Society endeavors to maintain a neutral stance on the views and research conclusions of its members.

### DISCUSSION OF THE 1810 MAP OF GALVESTON BAY

Tom Oertling, local historical researcher and nautical archaeologist, gave an review of the details written in Spanish in a map of Galveston Bay dated around 1810-1816 which had been obtained by the Society from the Mexican General Archives in Mexico City last August. In addition, Tom presented historical information he had researched on map sites of habitation along the Trinity River and on Bolivar Peninsula and offered a conjecture of possible purposes for the map's use based on close observation of the information contained in it.
