SPECIAL PRESENTATION

C.J. Christi, World War II researcher, author of over 100 articles, boat and air pilot, gave a talk on his book, World War II in the Gulf of Mexico: a War Close to Our Shores (2005), the war which took place over the months of May, June, July, and August of 1942. Christi's book contains extensive accounts of information obtained through the author's dedicated personal research of English, American and German military and naval archives, and includes numerous interviews with surviving German U-Boat captains and crew members. He was a member of the Verband Deutscher U-Bootfaher, an organization of German submarine veterans. A complete list of all the German U-Boats with their captains and crew members is given in the book, along with many photos and maps of U-Boat movements during the years of heavy predation upon American merchant marine ships. Mr. Christi's book pays tribute to the contributions of the American merchant marines during World War II, the unsung heroes of the war whose casualty numbers were almost as great as those of the U.S. Marines.

The author, born in Eunice, LA in 1929, was a graduate of Aviation Cadet Training in the U.S. Air Force, and from multi-engine school at Vance Air Force Base. He finished heavy bombardment training at Randolph Air Force Base in San Antonio, TX in 1951, and flew combat tour B-29s over North Korea. Following this war, he attended McNeese State University where he majored in English.

The President called the meeting to order at 6:30 p.m.

MINUTES

Minutes of February 14, 2006 were read to members present and were approved. Copies had been sent out on-line by the President along with the agenda for this meeting and announcement of the speaker.

TREASURER'S REPORT

Treasurer, Jerry Eubank, presented a written report showing a beginning balance on 2/14/06 of \$3,557.65, and an ending balance on 3/21/06 of \$3,563.65.

C.J. CHRISTI ON VIDEO

Member-at-Large, Don Peak, who had engaged author C.J. Christi to speak to the society this past February on his research on German U-boat attacks on American ships during World War II, announced that a video showing Christi's work was scheduled to appear on television's History Channel.

SPECIAL PRESENTATION

Mike Bailey, Second Vice-President of the Society and Curator at the Brazoria County Historical Museum, gave a talk and slide presentation on The Texas Navy - The Little Navy That Could, first established in 1836 with four ships, and on the second Texas navy which was established in 1837 consisting of six ships, including the famous steam-powered naval vessel Zavala, the remains of which are said to lie buried beneath a wharf parking lot on Galveston's bay side. Among subjects shown, slides depicted images of early naval history as reflected in Texas currency, as well as firearms used by the navy, photos taken from the Texas State Library Papers. Mike also handed out Xeroxed copies of a legal document between the U.S. Government and the Republic of Texas setting forth articles of agreement on the April 11. 1838 Texas Convention to terminate reclamations of the former government of the Texas Republic for the "capture, seizure, and detention of the brigs Pocket and Durango" and for "injuries suffered by American citizens on board the Pocket".

Also mentioned was the Battle of Campeche on May 13, 1843 at which time the navy of the Texas Republic consisting only of ships under sail prevailed over the steam-powered vessels of the Mexican Navy, this battle occurring two years before the Texas Navy of the Republic was incorporated into the U.S. Navy.

NEW BOOK ON LAFFITE

Laffite researcher and Advisory Board Member Pam Keyes of Miami, OK mentioned in a recent e-mail the publication of a new book, *Patriotic Fire* which has a main focus the participation of Jean Laffite and the Baratarians under his command in aiding General Andrew Jackson at the Battle of New Orleans.

SPECIAL PRESENTATION: "WHO WROTE THE JOURNAL"?

Advisory Board Member, Dr. Reginald Wilson, continuing his discussion on who wrote *The Journal of Jean Laffite: the Privateer-Patriot's Own Story*, spoke on the history of Laffite pretender John Matejka who for years had posed as the great-grandson of Jean Laffite, calling himself John Andrechyne Laffite. Advisory Board Member Jean L. Epperson called attention to the fact that Dr. Wilson had spent many hours on collateral research of John "A."'s (John Matejka's) family lines, using as his sources census, retirement and Social Security records, and various "copy books", or diaries, of medium and small size, alleged to have belonged to Jean Laffite and which are currently housed at the Sam Houston Library and Research Center in Liberty, TX. Dr. Wilson accompanied his talk with a slide presentation showing some of these items.

ARCHIVE REPORT

President Mike Eubank introduced Member-at-Large Ed Jamison as Chairman of a newly formed archival committee to include, at present, Ondree Kuhn, Lou MacBeth, and Secretary Dorothy Karilanovic. The committee had met a few days before to look over the collection of documents remaining to be processed, and had discussed briefly ideas for collating, cataloguing and filing them.

Ed also asked for a discussion on whether or not documents not directly related to Laffite history should be kept on permanent file. Third Vice-President Jim Nonus said that he would, first, like to see the documents before a decision to discard.

WARREN STAUFFER GIFT

Jean Epperson showed members a framed print of a painting by Drummond of the "blacksmith shop" in New Orleans' French Quarter, said to have been owned by the Laffites. The print was given to the Society by Member-at-Large Warren Stauffer of Bourne, MA and Longboat Key, FL. The Society also received from Mr. Stauffer two

letters dated January 2 and January 27, 2006, referring to possible buried treasure in "an old Galveston cemetery".

THANKS TO OUTGOING PRESIDENT AND TREASURER

Third Vice-President Jim Nonus and the Secretary expressed appreciation before the group for the outstanding contributions to the Society by Mike and Jerry Eubank during their tenure as President and Treasurer respectively, throughout which they gave unstintingly of themselves in multiple roles.

Mike Eubank discussed briefly the duties and expectations for new officers to take under consideration in the next term.

EXCAVATION REPORT FROM JUNE 14 DIG

Co-Coordinator of Research, Sheldon Kindall, stated that one of two courtyards behind the space formerly used as the Laffite Society meeting room at 2021 Strand has a brick floor at 20 cm. below ground. Slate was found at 10 cm., below which there was coarse sand. The objective of this investigation was to search for artifacts from the Battle of Galveston during the Civil War era. (Note correction: Minutes of June 20 stated incorrectly that the excavation on June 14 was held at 1417 Harborside Drive.)

NOMINATION OF OFFICERS FOR 2006-2008

SPECIAL PRESENTATION

President Jim Nonus distributed Xeroxed copies of an excerpted letter from a newspaper, *Poulson's American Daily Advertiser*, *Vol. XLVII*, *Number 12,922*, *Thursday Morning*, *April 23*, *1818*. The main focus was on an extract from Natchez, March 26, 1818 of a letter from Dr. John Sibley in Natchitoches on March 16, 1818 to Dr. John H. Robinson of Natchez, reporting the arrival from Galveston of an "extraordinary assemblage of French gentlemen with a large quantity of warlike stores . . . and farming tools", reputed to be intent on creating an "asylum for discontented Europeans".

According to the letter, prior to this arrival, "Lafite (sic) the younger" had brought into Galveston the 450 ton Spanish ship Campeachy with a cargo of \$360,000.00.

Jim commented that it was tempting to speculate that Galveston, once known as Campeachy, was so named in association with Laffite's capture of this valuable prize. The President then presented to newly elected Archivist, Ed Jamison, a 32 inch by 42 inch placard showing an enlarged reprint of the letter for the Society's archive.

SPECIAL ACKNOWLEDGEMENT

President Jim Nonus extended thanks and appreciation to Member-at-Large Clifford Johnson, and to Jodie Wilson and Kay Schwartz, all associates of Karen Derr Realty, for acting as hosts and tour guides for members to view the newly restored Galveston mansion, The Lasker House, which was the Galveston Historical Foundation award winner for 2006 and the site for this date's meeting of the Society. Members were feted with hors d'oeuvres and wine and enjoyed from the great height of a newly constructed deck and Widow's Walk a grand panoramic view of the Gulf and East End historical district.

TRAVEL & PREVIEW OF MEETING

The 10 members signed up for travel to Liberty, TX for the special event meeting to view the Jean Laffite collection at the Sam Houston Regional Library assembled at 9:00 a.m. in the historic Galveston home of Member, Kay Schwartz prior to a 9:30 a.m. departure. While in route to their destination in the capable hands of their van chauffeur (President Jim Nonus), R. Dale Olson gave a preview of the day's planned events along with some background history on *The Journal of Jean Laffite*, the original of which, along with related memorabilia, is now on display at the Library as the subject of interest for this date's meeting.

Following a savory lunch at Casa Don Boni Mexican Restaurant in Liberty from 11:30 a.m. to 12:30 p.m., hosted by Dr. Reginald and Mrs. Betty Wilson, the van travelers, who by then had joined with remaining attendees for the meal, gathered at the Library for the special lecture presentations.

NEW INFORMATION ON JEAN LAFFITE'S DESCENDANTS

To start off the meeting, Dr. Reginald Wilson showed members an original copy of the 1958 translation of *The Journal of Jean Laffite* and a copy of French scholar Gene Marshall's translation, pointing out facts in each and differences between the two. Dr. Wilson then presented a brief report on excerpts from a paper by Benjamin D. Maygarden entitled *The Silent Legacy of the Laffites' Private Lives*, presented at the 47th annual meeting of the Louisiana Historical Association, March 18, 2005, in Lafayette, LA. According to the paper, Maygarden's research suggests that Jean Laffite may have been the father of "Adele", the "natural daughter" of Catherine Villard, who eventually became the mother of 11 children, indicating the possibility of a previously unknown line of descendants of Jean, the celebrated privateer.

ROBERT SCHAADT'S OVERVIEW OF THE JOURNAL

Director and Archivist of the Sam Houston Library, Robert Schaadt, discussed the history of *The Journal* and the controversy surrounding its authenticity, as well as evidence of claims of Jean Laffite's death at sea in 1823. Mr. Schaadt expressed his continued interest in efforts to verify the document's authenticity possibly with the aid of new technology, and also urged members to push onward in the search for a primary source of information, which may be in private hands, of the Spanish testimonials relating to the 1821 death and burial of Pierre Laffite in the Yucatan.

LAFFITE COLLECTION

Following the talks, Darlene Mott, Librarian was on hand to show members the main Laffite collection on display — an index of 30 pages consisting of the Gov. Price Daniel collection, the Audrey Lloyd collection, the John Andrechyne Laffite collection, and the Stanley Arthur scrapbook. Members were able to see, inspect and handle books and other items of the Laffite collection as well as Laffite Study Group publications and newsletters.

THE JEAN AND PRICE DANIEL HOUSE

Following the lectures and viewing of the Laffite collection at the Library, Dir. Robert Schaadt conducted a tour of both floors of the former Texas Governor Price Daniel's mansion a short distance from the Library, built in 1984 and, according to the literature, "patterned after the original 1856 plans for the Texas Governor's Mansion". The Greek-style structure with 6 Doric columns now houses mementos of the public life of Gov. and Mrs. Price Daniels who is the great-great-granddaughter of General Sam Houston who practiced law in Liberty, TX during Texas' struggle for independence.

The Society extends thanks and appreciation to Dir. Robert Schaadt, Dr. Reginald Wilson who organized the day's program. Also, to Darlene Mott, Librarian and Linda Young, Research Assistant for arranging the displays of books and other items of interest, and for providing Xeroxed copies of archival lists to members.
