#### CALL TO ORDER

The President called the meeting to order at 6:10 p.m.

#### SPECIAL TOPIC

"PRIVATEER SEAL"
by

#### REGINALD WILSON

Dr. Reginald Wilson spoke on his research efforts to trace the origin and use of a privateering seal, found on page 212 of The Journal of Jean Laffite; the Privateer-Patriot's Own Story on which also appears a signature of Jean Laffite, and also on page 101 of the book Prince of Pirates. The original seal which is said to have had a paper border incorporating silver and gold paper depicts an eagle grasping a serpent in its beak. Other elements in the seal remain to be confirmed: a possible "armadillo" on

which the eagle is perched (some say it may be a "crown with 5 points), lightening bolts in the eagle's talons, and what may be the letters "No." for "Number" or the number 13; also letters YSD. Dr. Wilson distributed Xeroxed copies to members of 3 representations, one in color, of the seal, and called for close examination of the seal's elements in an effort to identify them.

Following his talk, the President thanked Dr. Wilson and also acknowledged the early research contribution in the discovery of the seal by Member-at-Large Pam Keyes, former editor of The Laffite Study Group newsletter.

#### **MINUTES**

The Secretary read the Minutes of the April 14 General meeting which were approved as read.

#### TREASURER'S REPORT

Second Vice-President Kathy Modzelewski, standing in for Treasurer Jim Earthman, reported a balance in the treasury of \$1,238.60.

#### **MEMBERSHIP**

SVP Kathy stated that there are now 89 paid members of the LS.

#### SPECIAL EVENTS

President Dale Olson, standing in for TVP Jim Nonus, reported on the upcoming trip to Lafayette, LA May 29 at which he will moderate a panel at the Southwest Society of Archivists entitled "In Search of Jean Laffite: Archival vs. Library Holdings Relating to Laffite-Era Privateering, the True Story." The panel consists of the following persons:

- Sally K. Reeves, New Orleans Notarial Archives, New Orleans: "Privateering in the Gulf of Mexico: True Stories from the Notarial Archives, 1805-1815."
- 2) Robert L. Schaadt, Director-Archivist, Sam Houston Regional Library, Liberty, Texas: "The Jean Laffite Journal; its History and Controversy."
- 3) Barbara Rust, Archivist, NARA (National Archives and Records Administration), Fort Worth Region: "Piracy and the Law: New Orleans Federal Court Records, 1806-1820.

The President stated that, following the meeting on May 29 in Lafayette, those members who wished to do so would be traveling on to St. Martinville, LA for 2 days' stay at The Old Castillo Hotel on the Bayou Teche, and a visit to surrounding sites of historical interest.

#### OFFICERS' JOB DESCRIPTIONS

The Secretary reported that she was going to place a description of each officer's job description in the respective binders now housed in the LS archive room at Eiband's, where, following election of new officers, the forms could then be reviewed and amended as needed.

#### BROADCAST TAPES OF HISTORICAL VINGETTES

Press Director Dave Roberts presented an audio tape of a script he had written and recorded on Jean Laffite. Dave proposed that 52 tapes would be needed for presentation over Galveston radio station KGBC, and called for volunteers to help write the scripts in a format of 3 double-spaced pages, the text not to exceed 3 minutes in reading time. Member Susan Hunger suggested that topics be assigned to volunteers by the Press Director.

The President appointed a committee to oversee preparation of the scripts, designated as follows: Kenneth Deaton, Jean L. Epperson, Dorothy McD. Karilanovic, Jeff Modzelewski, and Don Peak.

The President suggested that, following election of new officers, an ad hoc meeting be called to include out-going officers and newly elected ones, to discuss Board duties and new options.

#### VOLUNTEERS FOR PROVISION OF REFRESHMENTS

The President mentioned that, following election of new officers, members might want to consider assignments on a voluntary, monthly basis to provide refreshments at the LS meetings so that this effort can be more equally shared.

#### AREA EVENTS FOCUSSING ON LAFFITE

Descriptive information was provided announcing (1) that at the International Oleander Society meeting at Moody Gardens, May 16, 1998, Dr. Stephen Curley of Texas A.&M University, Galveston, would speak on "The Popular Images of Jean Laffite." and "The Galveston Sea Chantey in Oleander Time." 2) A new 18-minute film on Laffite, by producer Grant Mitchell and Associates has been completed, depicting "The Last Dinner on Galveston Island," which refers to a gathering of Laffite and some of his associates prior to dissolution of his commune and his departure from Galveston Island in 1820. Historical figures Jane Long and Lt. Kearny appear in the film as "ghostly figures" in retrospect. TVP Jim Nonus will have a supporting role in the film which also focusses on 3 Galveston locations: the sailing ship Elissa; an outdoor night scene in the sand dunes of east Galveston; and an interior dining room scene filmed in the 19th century Letitia Rosenberg House. The film is to be shown alternately with "The Great Storm" at Galveston's Seaport Museum, said to begin in late summer.

#### NEW TRANSLATION OF THE JOURNAL OF JEAN LAFFITE ...

The President announced that Prof. Tom Watson of Lake Charles has arranged for Prof. Jean Marshall of McNeese University, linguist and scholar in the French language, to begin a new translation of the <u>The Journal of Jean Laffite: the Privateer-Patriot's Own Story</u> in order to provide an alternative scholarly opinion as to accuracy in translation and in an attempt to verify the authenticity of other linguistic elements expressed by the alleged French-speaking author of the controversial journal.

#### NEW RESEARCH SOURCE ON JEAN LAFFITE

The President stated that Laffite researcher and author Robert Vogel informed him that in a volume of documents from the Cuban Archives, housed at The University of Minnesota, he had located a reference to Jean Laffite's escape from a Cuban prison in 1822.

#### ACKNOWLEDGEMENTS, REFRESHMENTS

Thanks extended to Louise Martin for providing home-baked chocolate cookies and to Dale & Diane Olson for beverages and other refreshments.

#### BROADCAST TAPES OF LAFFITE HISTORICAL VIGNETTES

Press Director Dave Roberts distributed copies to members of 28 topics he had thought of, relating to Laffite history, and called for volunteers to consider choices of topics they might like to write on. Members are to submit their choices to Dave at a subsequent meeting to insure that there will be no overlap.

#### NOMINATIONS OF NEW OFFICERS

#### INFORMATION ON THE BEALE CODE-LAFFITE CONNECTION

#### CULP CEMETERY DISCOVERY

Reginald Wilson discussed on-going activities relating to verification of the alleged burial site of Jean Laffite in Alton, Illinois, according to a statement from John A. Lafflin describing a trip he had made with his grandfather Jules Laffite in 1922, during which the latter led John A. to a spot surrounded on a small hill where

there was a small iron fence, and indicated it as the place of burial of Jean Laffite, which he [Jules] said he had last visited in 1854.

#### LETTER FROM PAM KEYES RE DE LA PEÑA DIARY

Reginald Wilson showed members a letter he had received from Member Pam Keyes in which she stated she had found in the book, Legends & Lies, Great Mysteries of the American West, by Dale Walker (1997), a claim made by autograph specialist Charles Hamilton that the José Enrique de la Peña diary written in 1836 and published in the 1950s was a forgery created, in addition to The Journal, by John A. Lafflin. Hamilton's claim was based on the fact that "the two works had certain phrases that were similar, but one was in Spanish and the other in French."

Pam Keyes plans to contest this claim at an upcoming meeting and to show the Peña book and samples of phrases for members' interest.

## SPECIAL PERFORMANCE by STRAND THEATRE TROUPE

Members of the cast of a new musical-historical stage production, <u>Jean Laffite</u> of the Maison Rouge, presented a staging of one dramatic scene from the play soon to have its world premier on July 9 at the Strand Theatre in Galveston. The performance was very well received and congratulations extended to the play's author and director William Burford, Executive Director of The Strand Theatre, and to the talented cast of players.

Plans are being considered for a special event reception and attendance as a group of LS members.

## SPECIAL PRESENTATION by R. Dale Olson "SACCARAP, AN EARLY CITY ON GALVESTON ISLAND"

R. Dale Olson, as a final presentation of his tenure as President of The Laffite Society for 1996-1998, spoke about the early city of Saccarap. which was located on the east end of what is now called Galveston Island from about 1835 to 1837. Saccarap extended from what is today 14th street east and was bordered on the north by what is now Harborside Drive (Avenue A), and on the south, by the island's main thoroughfare, Broadway. The city, said to have been established by settlers from

Maine who brought with them the Indian name of "Sacarrap," remained in existence for only a shot while, its demise partly a result of the destruction by a bore worm of Turner's Wharf which had served as the port of entry for passengers and commerce. At this time the center of business activity also shifted further West to what is probably now the present commercial center of the city of Galveston.

The story of Saccarap will appear in an upcoming issue of <u>The Laffite Society</u> Chronicles.

#### MINUTES

Due to absence of the secretary, Minutes of the June 9th meeting were not available. Archivist Richard Rasche, standing in for this date's meeting, provided an outline of the Minutes from which the Secretary might prepare a final version.

#### NOMINATION OF NEW OFFICERS

Parliamentarian Diane Olson presented the slate of nominees for Board offices for 1998-2000, all of which were voted in by acclamation.

#### BOARD MEETING OF OLD & NEW OFFICERS

A meeting of both groups of officers will be held at 6:00 p.m. on July 22 to review duties of respective positions and objectives for the coming term.

#### HENDRICK'S CASTLE ON THE MAISON ROUGE SITE

President Dale Olson mentioned he had been in touch with Don Henricks [sic] from California, a descendant of the Hendricks family who had built the late 19th century mansion on the alleged site of Jean Laffite's Maison Rouge, and great-grandson of George Johnson who also had lived in the house.

#### CARTAGENA FLAG

FVP Jean Epperson reported she had sent a letter prepared by the LS Secretary in Spanish to the National Museums of Venezuela, SA to request a copy of a design or picture of the Cartagena revolutionary flag. Jean is in the process of having an artistic rendering in color made of the flag in accordance with the details of its description she has at present. It is intended that this will be reproduced in an upcoming issue of THE LAFFITE SOCIETY CHRONICLES.

#### CULP CEMETERY SEARCH, ALTON IL

Reginald Wilson reported that his relative who is searching for the alleged burial site of Jean Laffite in Illinois had contacted a man who had been employed by the cemetery from 1930s-60s, bu that this individual claimed to know nothing of the Laffite grave site, which had been supposedly surrounded by a small iron railing. The former employee made reference to another person, s "grave digger," now deceased, who might have known some of these details.

#### THE LAFFITES AT BARACOA. CUBA

In a letter to Reginald Wilson, Laffite researcher in France, Patrick Laffite, reported that he and a group of Laffite researchers have located evidence that Pierre, Jean, and Dominique Youx were in Baracoa, Cuba in about 1798. No sources for this information were provided.

#### DAVID ALLEN, LAFFITE RESEARCHER

Reginald Wilson mentioned he had acquired a copy of a letter originally sent to Gov. Price Daniels, from David Allen, then a student at a New York college preparing a Master's thesis on Jean Laffite. Reginald, who answered the letter, said that David Allen mentioned he had taught school in Alton, Illinois.

#### LIGHTS OFF/LIGHTS ON

The power outage that earlier in the evening had made it necessary to conduct the LS meeting by candlelight and dusk ended about 7:57 p.m.

Dale Olson thanked Editor-of Publications Jeff Modzelewski for his dedication and excellence over the last four years in editing and preparing for print all material for THE CHRONICLES, and for his steady effort to bring up to date all issues of <u>THE LAFFITE SOCIETY CHRONICLES</u> from inception of the Society in Aug., 1994, to February of 1998.
- 2) The President also acknowledged Jeff Modzelewski's careful documentation and incorporation into a computer data base of all of the Society's financial transactions since its inception in August, 1994.

#### REFRESHMENT COMMITTEE

A suggestion was made that the new Program Chairman for 1998-2000 (FVP Dave Roberts) might want to call for volunteers on a rotational basis to provide refreshments at each LS meeting, and to establish a guideline for expenses for such

refreshments. Members are to be reminded at each meeting to contribute what they can at monthly meetings toward the cost of refreshments. A suggestion was also offered to publish in The Chronicles a request of members for ideas, topics, as well as entire write-ups for radio tape material.

#### PRIVATEER SEAL

Reginald Wilson stated that Robert Schaadt, Director of the Sam Houston Regional Library, has requested a copy of Laffite's privateer seal, along with the legend, to mount in an area near the display case containing the original Journal of Jean Laffite.

#### PRESENTATIONS ON RESEARCH

Reginald Wilson reported on several subjects of research interests, as follows:

1) Aaron Burr's Daugh(er, A Corsair's Captive?

Reginald Wilson reported that Aaron Burr's daughter, Theodosia, wife of Joseph L. Alston, Governor of South Carolina, was possibly on a ship ("The Patriot") captured by Laffite's men. Charles Nathan Tilton may also have been on the ship, although this information was never claimed by him or his descendants. Reginald showed to members a small picture of Annie Barber Tilton, 1817-1883, wife of Charles Tilton - a photographic enlargement made available by Member-at-Large Pam Keyes.

# 2) Culp Cemetery Research

Reginald stated that his cousin Paul Gardiner is still in the process of researching the Culp Cemetery for the location of Jean Laffite's grave. He is attempting to find individuals who are old enough to remember the history of the local residents and the cemetery. Reginald said he hopes to provide information for a follow-up article of one that appeared in a previous issue of The Chronicles, "A Visit to Laffite's Grave." Mr. Gardiner's report and photos will be forwarded to the Editor of Publications for the next issue.

# 3) "Registry of Deliberations"

Continuing his presentation, Reginald spoke about a document known as the "Registry of Deliberations," which contained the rules and regulations, "or constitution" written by the founders of the Galveston commune. The original document in French and unsigned by Jean Laffite is housed in the Fort Worth Archive. Reginald said he would place a copy of the original document along with an English translation in the Sam Houston Regional Library and Research Center at Liberty, and in The Laffite Society Archives.

# 4) Taped Telephone Conversation with Jane Surratt

Reginald provided the Secretary with a typescript of his taped telephone conversation with Jane Surratt, wife of John Surratt who is the nephew of Lacey Laffite, wife of John Andrychene Laffite. Jane Surratt stated she and her husband had always believed that John A. Laffite's great-grandfather was Jean Laffite, as he always claimed, because of the possessions that had come down to him: "All he could talk about was his ancestor," Jane said. Further, although Jane's husband John said he never saw any trunks in John A.'s house that burned in 1959, Jane Surratt did say that they knew that a third trunk had been "thrown out of the window" during the fire, which John A. had widely claimed had occurred, this trunk said to have contained the original Journal of Jean Laffite. Of further interest, Jane Surratt claims to have a ledger "with some writing in it" which she says belonged to Jean Laffite's family. Reginald says he inquired if she would consider sending the ledger to him to look at, assuring her that it would be safely returned in due course. The question remains, is this ledger an original document with hand writing by Laffite, or a forgery by the hand of John A.?

# NEW TRANSLATION OF THE JOURNAL

Reginald Wilson received a letter from French language scholar and linguist Gene Marshall of McNeese University, Dept. Of Languages, Lake Charles, LA. Mr. Marshall reported on his findings following his recent translation of <u>The Journal of Jean Laffite: The Privateer-Patriot's Own Story</u> which was requested by The LS and facilitated through the assistance of Prof. Thomas Watson of Lake Charles. Some comments in the letter included the following:

- 1) Handwriting in The Journal is the same throughout.
- 2) Different writing pens wee used at certain points.
- The author of The Journal was probably a speaker of French, Spanish & English, with the primary language being French.
- 4) Style of French language used is that of the pre-1850 era.

# THOMAS BEALE CIPHER REPORT

The Secretary reported that in June, '98, The LS received a "second installment" for the official LS archive file of information from Richard B. Smith and The Company of West Yorkshire, England on their findings resulting from their on-

going deciphering efforts of the Thomas Beale Codex which dates from 1820. The carefully prepared and detailed "report" included information on the history of the Knights Templar Order in which Smith & Company allege that Jean Laffite, alias Thomas J. Beale, was a member and held the title of Prieuré de Sion (Prior of Zion). A photocopy was included of an article dating from the 1980s describing the latest Prieuré de Sion title holder in France. The Secretary stated that Richard Smith, the principle decoder of the cipher, said that upon completion of his work it is the intention of his group to travel to the United States to present his findings to the U.S. Government, at which time he will apply for licenses to excavate on a site presently owned by the U.S. Govt. Smith said that map coordinates and other identifying information for the approximate site of an alleged vast amount of treasure described in the codex are forthcoming from his work in progress. According to the Secretary, it is Smith's belief that the results of his findings will set right once and for all the correct history of the fate of Jean and Pierre Laffite whom he believes met their deaths in Mr. Smith also stated that he may try and arrange a visit to Galveston during his travel to the U.S. to present his findings to The LS.

# PHOTOS ON CULP CEMETERY

Reginald Wilson showed the photos taken by his cousin Paul Gardiner in the general vicinity of the Culp Cemetery in Alton, Illinois. Also available to see was a Xeroxed copy of a small hand-drawn map showing the psosible location of the cemetery.

# EROS SATELLITE PHOTOS OF CULP CEMETERY

Member Norman Sachnik has offered to write to request information on obtaining satellite photos of the site in Alton, II. said to be the Culp Cemetery where Jean Laffite may be buried. The specific focus of such a search would be to try to identify traces of iron ornamentation buried in the soil, the remnants of a railing encircling the grave site, described by John A. Laffite, alleged great-grandson of Jean Laffite.

#### LAFFITE PRIVATEER SEAL

Reginald. Wilson presented a copy in color of the Jean Laffite Privateer Seal with Jean Laffite's signature to the Editor-of-Publications for inclusion in The LS CHRONICLES. Dr. Wilson has generously offered to underwrite a portion of the cost of printing and publication in color of this unique document for the forthcoming Oct. issue of THE LAFFITE SOCIETY CHRONICLES.

#### SPECIAL PRESENTATION

"CULTURAL ECOLOGY OF GALVESTON, 1816-1821" by ROBERT C. VOGEL

First Vice-President Dave Roberts introduced the special lecturer, Robert C. Vogel, archeologist, author and Laffite researcher.

Against a descriptive background of revolutionary & Royalist forces all contending for control of the strategic barrier island site of Galveston, the focus of Mr. Vogel's talk was a summary of his research, thought and efforts to portray a true picture of the continual struggle by the Laffites and their associates to govern and maintain a harsh material existence for members of the Galveston commune of 1817-1821 where a polyglot population of several hundred lived in poorly constructed palm-thatched huts, often suffering from lack of nourishing food, clean water, and from the effects of disease.

The topic of tonight's talk was based on a presentation Mr. Vogel had given in Pensacola, FL, and is intended for publication.

# CUBAN ARCHIVE CORRESPONDENCE

The Secretary reported she will submit to the Editor for eventual publication in THE CHRONICLES four letters written by Pierre & Jean Laffite in 1817 which she had translated from Spanish, obtained from a copy of a text of documents originally housed in the Cuban National Archives. According to Robert C. Vogel, author and Laffite researcher, The Cuban material is more comprehensive than the documents filed in the Archivo de Indias in Seville; it is ... closer to the original sources of the correspondence and reports (the Spanish consuls in New Orleans, the captain-generals in Havana, and the officials in Mexico) and contains some material that was never copied into other archives." The letters of August 16, 1817 and September 1, 1817, are of special note, according to Robert Vogel.

#### **BEALE CIPHERS**

The Secretary stated she had received a faxed letter from Richard B. Smith of THE COMPANY, West Yortkshire, Eng., who is is the process of decimbering the Thomas Beale

ciphers reported to have information regarding the burial site of a large treasure. According to Mr. Smith, it is his belief, based on information he continues to retrieve from the ciphers, that Thomas Beale may have been an alias of Jean Laffite. In a short, faxed communication from Mr. Smith Sept.23, 1998, he mentioned that he had received "a code readout [giving] the name of Jean's son." In her reply to Mr. Smith of Sept. 29, the Secretary reported she had mentioned the names of "Jules" and "Glenn" as the names of Jean's sons, and had asked Mr. Smith what was the name he had retrieved from his decoding efforts. His reply on Oct. 31, was the following: "Re. Jean's son's name: Sorry, but at this moment in time still collating further data." In this letter, Mr. Smith gave information on book title he believes that members of The LS might want to acquire, information as follows:

TITLE: THE BEALE TREASURE: "NEW" HISTORY OF A MYSTERY Auth.: Peter Viemeister, published by Hamilton's, P.O. Box 932, 155 W. Main St., Bedford, VA, 24523. Tel.: 540)586-5592; Fax.: 5400586-6235. Price: \$22.50. Of further note in Mr. Smith's fax of Oct. 31, he states:

"Having read the above book, there is a positive line of connection between 'Beale Senior/Junior, and Jean, Pierre, and Dominique. Beale Senior's plantation perfect hide-out for the Laffites. Beale Junior too young to lead so-called hunting trip in the 1820s (approx. 19 yrs. Old). However, impossible for 'Jean' to imperjsonate junior; but able to impersonate father."

As has been mentioned previously, Mr. Smith has stated that he intends to make the finished results of his project known to the U.S. Govt., at which time he will also apply for licenses to excavate. As stated previously, if possible, it is his intention to also make a trip to Galveston at the time of his visit to the U.S. to present his findings to The Laffite Society..

# JOHN DUCOIGNE

The Secretary mentioned she had received an inquiry from Mrs. Fred Brown of Dallas, Texas concerning genealogical information on an associate of Jean Laffite, John Ducoigne. With her letter, Mrs. Brown included copies of depositions made by John Ducoigne of his account of the governance of the Laffite commune on Galveston Island. These papers will be placed in The Laffite Society archive at The Eiband Gallery
